


Dear Members,

I have several items for your attention today, please read on:

### **Richland County COVID-19 Nonprofit Grant Program Launches today**

Thanks to support from our Richland County Commissioners, today we're opening our Nonprofit Grant Program for nonprofits in Richland County – we have \$500,000 to award. Some of the important eligibility criteria includes:

- Must be a 501c3 organization as recognized by the IRS and registered with the Ohio Secretary of State's office
- Have *40 FTE's or less* (part-time count as a  $\frac{1}{2}$  employee)
- Have *\$4M or less in 2019 operating revenues*
- Must have been *in operation on February 28, 2020* or prior
- The principal place of operation, or headquarters, for the nonprofit must be located within Richland County. If located outside of Richland County, the organization must have a Richland County address, and must be providing services in Richland County to be considered.
- Nonprofits must fit into one of two program fund categories:
  - Nonprofit Relief Grant program – funding organizations meeting basic or important needs (see [grant guidelines](#) for full definitions)
  - Arts, Culture, and Attractions program – funding organizations with a mission in arts & culture, or that serves a local attraction. (see [grant guidelines](#) for full definitions)



The maximum grant amounts are \$7,500 (for organizations with 2019 operating revenues of \$100,000 - \$4,000,000) and \$2,500 (for organizations with 2019 operating revenues of less than \$100,000). There are other eligibility requirements and exclusions, please [read the full grant guidelines](#).

This Round is currently being funded with dollars from the CARES Act being given by [Richland County](#). You can read [the full press release](#) here. We are in talks with additional entities so additional funds may be given and we'll keep you apprised of that.

This is not a first come, first served grant, all eligible applications will be scored. In the event of a tie in scoring, an earlier application would get a slight edge. So, you don't have to drop everything this morning to apply, but I would also recommend not waiting until the last minute if possible.

The grants will be announced on Monday, November 30<sup>th</sup>. It is important to note that we do expect to receive more applications than we can fund. If, however, additional money becomes available we will go to the next highest scoring group of nonprofits to award funding.

### **State of Ohio Bar & Restaurant Fund – Still accepting applications**

Earlier this week it was announced that the Bar & Restaurant Fund had only received applications from about 1/3 of eligible businesses. To refresh your memory, the State announced a \$37.5 million dollar program to provide support to the hard-hit bar & restaurant industry. You must apply to receive assistance, but if you are holding one of 30 different liquor control permit types – and you meet the requirements below – you would qualify for \$2,500 per location with a valid permit.

- These permit holders need to have had an active on-premise permit as of close-of-business October 23, 2020.
- The business does not have to be currently open but must have an active liquor license. You can check the status of your liquor permit [here](#). If it's active, it will be listed as "issued."
- After applying, a licensee will receive \$2,500 per unique business location.

### **State of Ohio Launches Small Business Grant Program**

The State of Ohio is still accepting applications for their \$125 million dollar program to offer assistance to small businesses with 25 or less employees. The grants are for \$10,000 per business and here is more about eligibility:

- The business must be a for-profit entity with no more than 25 Ohio employees as of Jan. 1, 2020.
- The business must also have a physical location in Ohio and earn at least 90% of annual revenue based on activities performed in and taxable to Ohio.
- The business must have been in continuous operation since Jan. 1, 2020, except for interruptions required by COVID-19 public health orders and have the ability to continue operations as a going concern.

>>>*Are you eligible if you have received other grants?* I believe that you could also receive funding through this program even if your business qualified for the PPP or our local grant – but because the funding source is the same for all of those programs, you cannot claim the same expenses as the others. And of course, these grants will show as taxable income as the rules are currently written.

## **Updates from the State**

I'm sure by now you have heard about what the Governor announced in his Wednesday evening address. The State is now asking businesses to enforce the mask mandate at your location, post [a sign on your door](#) requiring a mask to enter, and have said that for retail establishments they are creating a BWC team to enforce this. He also addressed some upcoming changes to the gathering rules – it sounds like for banquet facilities and the like.
